7. NEVADA WICHE 2027-2029 BIENNIAL BUDGET PRIORITIES

FOR POSSIBLE ACTION

Director Patty Porter will present updated recommendations for Nevada WICHE 2027-2029 biannual budget priorities for discussion and possible action:

- a. Request approval to ask for adjustment for Loan and Stipend account due to the increase in proposed WICHE PSEP support fees for 2027-2029 biennium. Nevada WICHE PSEP program fields being proposed for increase, Occupational Therapy, Physical Therapy and Pharmacy.
- b. Request approval to ask for increase in Loan and Stipend account PSEP program slots for the 2027–2029 biennium as follows: Occupational Therapy (3 slots), Physical Therapy (5 slots), and Physician Assistant (3 slots).
- c. Request approval to ask for the projected loan repayment revenue, which factors into Nevada WICHE biennial budget for 2027-2029, to be replaced by state appropriation and all loan repayment revenue collected by Nevada WICHE revert to the State of Nevada general fund.
- d. Request approval to ask for a Program Officer II position in addition to the Program Officer I position for the Nevada WICHE biennial budget for 2027-2029.
- e. Request flexibility from Nevada WICHE Commissioners for Nevada WICHE Director to adjust biannual budget requests for Administration and Loan/Stipend accounts.
